PROPOSAL

The proposed Zoning By-law amendment is the outcome of the Ellesmere Employment Study, which applies to the employment lands adjacent to Ellesmere Road and Canadian Road, between Warden Avenue and Birchmount Road. The proposed Zoning By-law amendment would restrict types of recycling/recovery facilities that could have adverse impacts on surrounding employment uses from the study area.

On November 13, 2013, City Council directed that the Chief Planner and Executive Director, City Planning undertake a study for the Ellesmere Employment Study lands, to review the existing land use permissions and regulations in the study area and determine if new policies and standards are required to reduce land use conflict, and if so, to bring forward new policies and zoning regulations for this area. As part of the study, staff have consulted widely with the community, including four consultation meetings, to gather input from residents, business owners and tenants and other stakeholders. 

Zoning By-law Amendment Appeal: If a person or public body does not make oral submissions at a public meeting or make written submissions to the City Clerk, attention: Yvonne Davies, Administrator, Scarborough Community Council, at the address set out in this notice or by Fax: 416-396-4301 before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision to the Ontario Municipal Board and may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.
