To consider a proposal to rename the public highway located north of Vandorf Street, extending easterly from Sheppard Avenue East as "Elaine Lennox Court".

The plan showing the lands to be affected may be seen in the City Clerk's Office, Secretariat, 3rd Floor, Scarborough Civic Centre, 150 Borough Drive, between the hours of 8:30 a.m. and 4:30 p.m. Monday to Friday. At its meeting to be held in the Council Chamber, Main Floor, Scarborough Civic Centre, 150 Borough Drive, on September 8, 2015 at 9:30 a.m., or shortly afterwards, the Scarborough Community Council will hear in person or by his or her counsel, agent or solicitor, any person who claims that his or her lands will be prejudicially affected by the naming and who applies to be heard with respect to the proposed naming.
