**PROPOSAL**

The application to amend the Zoning By-law proposes to introduce a number of additional uses under the existing Neighbourhood Commercial (NC) Zoning for the property at 2301 Brimley Road, 2329-2361 Brimley Road, 0 Commander Boulevard and 175 Commander Boulevard.

The application seeks to include as permitted uses:

- Educational Uses and Facilities;
- Personal Service Shops;
- Pet Services; and
- Gym/Fitness Centre Facilities

No new construction is proposed on the subject lands other than that which has already been approved under the existing approved site plan.

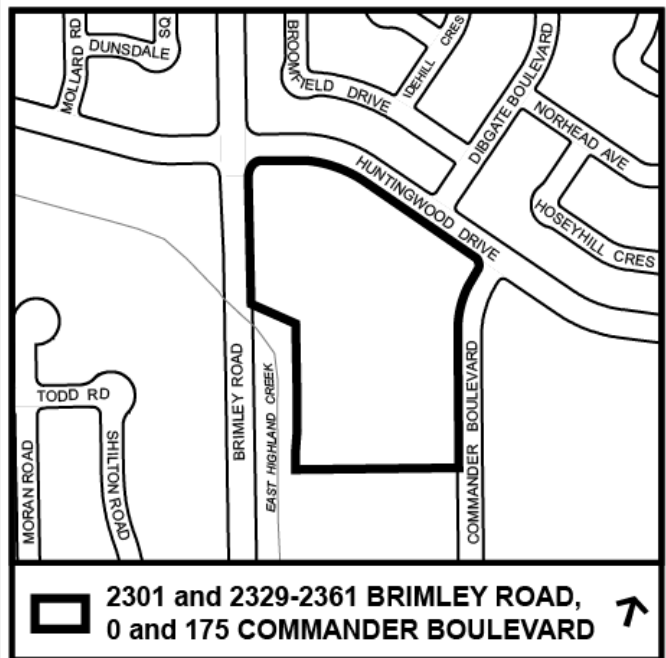
## FURTHER INFORMATION

**If you wish to be notified** of the passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk, attention: Yvonne Davies, Administrator, Scarborough Community Council, at the address set out in this notice or by Fax: 416-396-4301.

**Zoning By-law Amendment Appeal:** If a person or public body does not make oral submissions at a public meeting or make written submissions to the City Clerk, attention: Yvonne Davies, Administrator, Scarborough Community Council, at the address set out in this notice or by Fax: 416-396-4301 before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision to the Ontario Municipal Board and may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

**People writing or making presentations at the public meeting:** The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.
