REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

The permitted maximum floor space index is 0.75 times the area of the lot (127.88 m²).

The altered semi-detached dwelling will have a floor space index equal to 1.18 times the area of the lot (202.34 m²).

Section 7.5.3, By-law 6752

The maximum permitted floor space index is 0.75 times the area of the lot (127.88 m²).

The altered semi-detached dwelling will have a floor space index equal to 1.18 times the area of the lot (202.34 m²).
