**Car-share Vehicle Parking Area – Dovercourt Road –
Non-Delegated**

SUMMARY

Transportation Services is seeking City Council approval to remove a car-share vehicle parking area (CVPA) on Dovercourt Road. Transportation Services staff will be undertaking consultations with the various stakeholders and will continue with efforts to find a suitable replacement location for this car-share vehicle parking area in the area.

RECOMMENDATIONS

Transportation Services recommends that:

1. City Council rescind the car-share parking area for up to three car-share parking spaces for Car2Go vehicles on the west side of Dovercourt Road, between a point 30.5 metres south of Hallam Street and a point 11.0 metres further south.

Financial Impact

The revenue generated from the permits to the City will be lost upon the removal of this location [\$2,760.02 plus HST/year]. Funds to undertake the removal the signs in the estimated amount of \$200.00 is available within the Transportation Services 2015 Operating Budget.

DECISION HISTORY

At its meeting of May 6, 7 and 8, 2014, City Council adopted Item No. TE31.55, approving the installation of a car-share vehicle parking area on the west side of Dovercourt Road, south of Hallam Street.

ISSUE BACKGROUND

Transportation Services has investigated a request from Councillor Ana Bailão to remove or relocate the car-share vehicle parking area on Dovercourt Road, due to concerns raised by area residents and businesses over the impact that this area had on the available supply of on-street parking.

COMMENTS

Transportation Services reviewed the existing car-share vehicle parking area on the west side of Dovercourt Road, south of Hallam Street. This space was installed in 2014 for Car2Go. TTC service on this section of Dovercourt Road is provided by the 161 Rogers Road bus. A review of the surrounding area did not disclose any suitable locations for the relocation of this space at this time. Therefore, Transportation Services has no objections to the removal of this space as an interim measure with the understanding that consultations continue to find suitable alternate car-share vehicle parking area locations. The permit fees that were paid for this installation will be refunded to the applicant.

The removal of this location is supported by Councillor Ana Bailão and the Councillor has been advised of the recommendation of this report.
