Extension of Overnight On-Street Permit Parking Hours – Gore Vale Avenue

SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to extend the overnight on-street permit parking hours on Gore Vale Avenue, between Dundas Street West and Queen Street West from 12:01 a.m. to 7:00 a.m., seven days a week to 12:01 a.m. to 9:00 a.m. and 5:00 p.m. to 7:00 p.m., seven days a week and implement a 1-hour parking restriction between 9:00 a.m.to 5:00 p.m. and 7:00 p.m. to 12:00 a.m., seven days a week.

By extending the overnight on-street permit parking hours the Parking Enforcement Unit, Toronto Police Service, can effectively control long term parking, through tagging and towing operations.

RECOMMENDATIONS

Transportation Services recommends that Toronto and East York Community Council:

1. Approve the extension of the overnight on-street permit parking hours on Gore Vale Avenue, between Dundas Street West and Queen Street West from 12:01 a.m. to 7:00 a.m., seven days a week to 12:01 a.m. to 9:00 a.m. and 5:00 p.m. to 7:00 p.m., seven days a week. Amend the "one-hour maximum parking 8:00 a.m. to 6:00 p.m., seven days a week" regulation on the east side of Gore Vale Avenue, between Queen Street West and Dundas Street West, to operate between the hours of 9:00 a.m. to 5:00 p.m. and 7:00 p.m. to 12:00 a.m., seven days a week

FINANCIAL IMPACT

The amount of \$400.00 is available within the current Toronto Transportation Services 2015 Operating Budget.

ISSUE BACKGROUND

A request was received from Councillor Mike Layton, on behalf of area residents, to extend the overnight on-street permit parking hours on Gore Vale Avenue, between Dundas Street West and Queen Street West from 12:01 a.m. to 7:00 a.m., seven days a week to 12:01 a.m. to 9:00 a.m. and 5:00 p.m. to 7:00 p.m., seven days a week and implement a 1-hour maximum parking restriction between 9:00 a.m.to 5:00 p.m. and 7:00 p.m. to 12:00 a.m., seven days a week.

COMMENTS

Gore Vale Avenue, between Dundas Street West and Queen Street West, is a local street operating in a one-way northbound direction, on a pavement width of about 6.4 metres. There is no TTC Service on Gore Vale Avenue.

Permit Parking operates on the east side of the street from 12:01 a.m. to 7:00 a.m., seven days a week with a 1-hour maximum parking from 8:00 a.m. to 6:00 p.m. daily.

Parking is prohibited at all times on the west side.

Transportation Services has no objections to extending the permit parking hours of operation on Gore Vale Avenue, between Dundas Street West and Queen Street West.
