This letter is to confirm in principle the intention of PortsToronto to support the Waterfront Toronto Public Art Master Plan for East Bayfront by working with Waterfront Toronto staff on implementation of the commissions along the waterfront. **Public Art Plan** 

This letter is to confirm in principle the commitment of Daniels QQ Corporation and Daniels Waterfront Corporation ("Daniels") to coordinate our percent for art program for our development block within the East Bayfront precinct, with Waterfront Toronto's public art program as articulated in the East Bayfront Master Plan being brought to City Council for Approval this year.

In keeping with the intent of the East Bayfront Public Art Master Plan, Daniels will exercise the "on-site/off-site combination" option within the City's Percent for Public Art program and fulfill our Section 37 public art contribution through both an "on-site" commission, and an "off-site" cash contribution to one of the high profile public sites identified in the East Bayfront Public Art Master Plan. The total contribution amount will be determined with City Planning, in accordance with the City of Toronto's typical Percent for Art Program Guidelines, and the portioning to "on-site" and "off-site" opportunities will be negotiated with City Planning and Waterfront Toronto.

We are looking forward to working together with the City and Waterfront Toronto towards the commissioning of a holistic and dynamic public art program for the precinct that will set this neighbourhood apart from any other in the city.
