**RE:** Request for Endorsement of Events for Liquor Licensing Purposes – "Salsa on St. Clair"

**DATE:** April 8, 2015

The eleventh annual "Salsa on St. Clair" will take place on Saturday, July 4<sup>th</sup> and Sunday, July 5<sup>th</sup> St. Clair Avenue West between Christie Street and Humewood Drive on the East and Winona Drive on the West. I request that Toronto and East York Community Council declare "Salsa on St. Clair" an event of municipal significance open to the public.
