

Notice of Public Meeting

Proposed Changes to User Fees

Toronto City Council will be considering recommendations to pass by-laws to amend the City of Toronto Municipal Code Chapter 441, Fees and Charges, so as to adopt the changes to existing user fees and the new user fees that are proposed in the 2016 Preliminary Operating Budget. The 2016 Preliminary Operating Budget will be considered by City Council on February 17 and 18, 2016.

Attached to this notice is a listing of the changes to existing user fees [[Appendix A](#)] and new user fees [[Appendix B](#)] that are proposed in the 2016 Preliminary Operating Budget.

Any comments received after the Committee meetings will be processed to Council.

The Budget Committee will make its final recommendations on January 26, 2016, which will be forwarded for consideration by the Executive Committee at its special meeting on February 9, 2016 and to City Council at its special meeting on February 17 and 18, 2016.

While the 2016 Preliminary Operating Budget sets out the recommended fees, the appropriate Committee may change these recommendations and Toronto City Council may adopt rates that differ from the recommendations, including fees that are higher or

lower than the fees being proposed, and may adopt new fees not contemplated in the 2016 Preliminary Operating Budget.

If this matter is postponed at the Committee meeting or Council meeting or considered at a subsequent Committee meeting, no additional notice will be provided other than the information on the subsequent Committee or Council agenda.
