#### **Committee Decision**

The Planning and Growth Management Committee:

2. Forwards the revised presentation, from City Planning, to the Budget Committee, the City Manager and the Deputy City Manager and Chief Financial Officer, for consideration as part of the 2016 Budget Process.

#### **Decision Advice and Other Information**

The Planning and Growth Management Committee:

1. Requested the Chief Planner and Executive Director, City Planning and the Chief Building Official and Executive Director Toronto Building to review their division's organizational charts with a view to improving service delivery with the elimination of gapping.

2. Requested the Chief Planner and Executive Director, City Planning to report as soon as possible to the Planning and Growth Management Committee on the hiring of additional planners in the Community Planning area and the fee increases required to cover the cost of such additional staff in 2016, and that the report consider other needed positions within City Planning which could generate full cost recovery.

3. Requested the City Solicitor report as soon as possible to the Planning and Growth Management Committee on the need for additional Planning lawyers to meet the increased demand and whose cost could also be recovered through development fees.
