SUMMARY

Further direction from City Council is required on matters that have been appealed to the Ontario Municipal Board ("OMB").

RECOMMENDATIONS

The City Solicitor recommends that:

- 1. Council adopt the Confidential Recommendations to staff in Attachment 1; and
- 2. Council authorize the public release of the Confidential Recommendations, if adopted, with the balance of the Confidential Attachment 1 and Schedule "A" to remain confidential.

Financial Impact

Adopting this report will have no financial impact beyond what has already been approved in the current year's budget.

DECISION HISTORY

In September of 2012, City Council approved a development for this site in the form of a four-storey apartment building and 46 dwelling units that was intended to provide housing for seniors. The Council approval was appealed to the OMB by the Bedford-Wanless Ratepayers Association. After one pre-hearing before the Board, the appeal was subsequently withdrawn.

The property was subsequently sold to the current applicant. The church on site has been demolished and the lands remain vacant.

The current application was received by City Planning on May 5, 2015 and appealed to the OMB on March 3, 2016 on the basis that no decision was made in accordance with the statutory time frames.

At its meeting of June 14, 2016, North York Community Council considered Item NY15.46 Request for Directions report and recommended to City Council that the City Solicitor and appropriate staff to oppose the Official Plan Amendment and Zoning By-law Amendment appeals.
