Re: Request to recognize BIA - Restaurant patio expansion during TIFF Opening Weekend as event of municipal

significance for temporary patio expansion license for restaurant row

Dear Members of the Toronto East York Community Council and Members of City Council:

I am writing to request that the Entertainment District BIA King Street Restaurant Patio Expansions during Toronto International Film Festival opening weekend, taking place from September 8 – 11, 2016, be **recognized as an event of municipal significance**.

We are asking that this request be considered at the July 12th meeting of Toronto City Council.

The Toronto International Film Festival has grown to become the world's largest public film festival, with an annual economic impact measured at \$189 million. The BIA's partnership with TIFF will help to maximize the festival's benefits for local businesses, and enhance Toronto's status as a leading tourism destination.

With approval of the partial closure of King St. from University Ave. to Blue Jays Way, over the opening weekend, September 8 –11, TIFF has requested the BIA's support to assist King St. restaurants in obtaining temporary patio expansion licenses to occupy the sidewalk. (South side of King St. between John St. and Blue Jays Way and the north side of King St. between Simcoe and Ed Mirvish Way) The BIA will work with all operators to ensure everyone is in full compliance with Alcohol and Gaming Commission of Ontario.

I am respectfully requesting that the Community Council advise the Alcohol and Gaming Commission of Ontario that it has **no** objection to requests for temporary liquor license for patio expansion from September 8th to September 11th for the following establishments:
