SUMMARY

This staff report is about a matter that Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to obtain approval to amend a portion of the existing "No Parking, 8:00 a.m. to 5:00 p.m." regulation on the west side of Montgomery Road to be in effect for the hours of "8:00 a.m. to 2:00 p.m., Monday to Friday". This proposed amendment will allow additional on-street parking for the Montgomery's Inn Farmers' Market.

RECOMMENDATIONS

Transportation Services recommends that Etobicoke York Community Council:

- 1. Amend the existing parking prohibition in effect from 8:00 a.m. to 5:00 p.m. on the west side of Montgomery Road, between Dundas Street West and a point 200 metres south, to be in effect from 8:00 a.m. to 2:00 p.m. Monday to Friday.
- 2. Amend the existing parking prohibition in effect from 8:00 a.m. to 5:00 p.m., on the west side of Montgomery Road, between a point 200 metres south of Dundas Street West and a point 60 metres south of Allanbrooke Drive, to be in effect from 8:00 a.m. to 5:00 p.m. Monday to Friday.

Financial Impact

The estimated cost for amending the signs is \$1,000.00. These funds are included within the Transportation Services 2016 Operating Budget.

ISSUE BACKGROUND

The Ward Councillor, on behalf of Montgomery's Inn requested Transportation Services to review the potential for providing on street parking to accommodate overflow parking for the Farmers' Market and special events. A map of the area with the existing and proposed parking regulations is Attachment 1.

COMMENTS

Montgomery Road is a two lane road classified in the City's Road Classification System as a "Local" roadway. Within the subject area, a paved shoulder exists which is delineated by a solid white line from the travelled portion of the roadway. Currently, a "No Parking Anytime" regulation exists on the east side of Montgomery Road while a "No Parking, 8:00 a.m. to 5:00 p.m., Monday to Friday" regulation is signed on the west side. However, the associated by-law indicates that this regulation is in effect all days. Etobicoke Collegiate Institute is located on the west side of Montgomery Road south of the subject area. In addition, "No Stopping" prohibitions exist on both sides of Montgomery Road near the school that are in effect during morning and afternoon peaks.

In consultation with the Ward Councillor and staff from Montgomery's Inn, it was determined that the existing signed "No Parking, 8:00 a.m. to 5:00 p.m., Monday to Friday" prohibition be changed to "No Parking, 8:00 a.m. to 2:00 p.m., Monday to Friday". This regulation will deter long term parking generated by the school while accommodating the needs of Montgomery's Inn.
