# Parking Regulation Amendment – Upland Road

# **SUMMARY**

This staff report is about a matter for which Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to obtain approval to allow for the installation of a "No Parking from 8:00 a.m. to 5:00 p.m., Monday to Friday" regulation on both sides of Upland Road between Wilgar Road and Belvedere Boulevard. This proposed regulation will alleviate excessive long term parking of vehicles.

#### RECOMMENDATIONS

# **Transportation Services recommends that Etobicoke York Community Council:**

1. Prohibit parking from 8:00 a.m. to 5:00 p.m., Monday to Friday on both sides of Upland Road, between Wilgar Road and Belvedere Boulevard.

#### **Financial Impact**

The estimated cost for amending the signs is \$300.00. These funds are included within the Transportation Services 2016 Operating Budget.

#### **ISSUE BACKGROUND**

The Ward Councillor, on behalf of area residents, forwarded a petition signed by the majority of effected households, requesting Transportation Services change the existing the City-wide three-hour limit to a "No Parking, 8:00 a.m. to 5:00 p.m., Monday to Friday" regulation on both sides of Upland Road between Wilgar Road and Belvedere Boulevard. A map of the area with proposed parking regulations is Attachment 1.

## **COMMENTS**

Upland Road is a 6.1 metres wide road classified in the City's road system as a "Local" road. There are no sidewalks on either side of the street. Currently, parking on Upland Road is subject to the City-wide 3 hour maximum parking by-law.

Based on the petition received by the majority of affected residents and staff's examination of this matter, staff can support the request that the current parking regulations on both sides of Upland Road between Wilgar Road and Belvedere Boulevard, be amended to prohibit parking from 8:00 a.m. to 5:00 p.m., Monday to Friday. This proposed parking regulation amendment will further discourage parking on both sides of the road and will not only alleviate long term parking but will improve pedestrian safety.
