SUMMARY

This staff report is about a matter for which Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to obtain authorization for roadway alterations related to the 2016 reconstruction of Chapman Road. As part of this reconstruction, proposed is the construction of curb and gutter on both sides of the Chapman Road from west of Scarlett Road to west of Easthampton Drive. The proposed construction of curb and gutter on this section of Chapman Road will narrow the road to 8 metres.

RECOMMENDATIONS

Transportation Services recommends that Etobicoke York Community Council:

(1) Approve the alterations and modifications on Chapman Road, a road narrowing to 8 metres from a point approximately 25 metres west of Scarlett Road to a point approximately 24 metres west of Easthampton Drive, as indicated in Appendix "A", and generally shown on the attached drawing y16200.

Financial Impact

The funds associated with the proposed highway alterations on Chapman Road are included in the Coordinated Toronto Water & Transportation 2016 Capital Works Program, Contracts 4 (16ECS-TI-104LR).

ISSUE BACKGROUND

As part of the Coordinated Toronto Water & Transportation 2016 Capital Works Program, Contracts 4 (16ECS-TI-104LR), Chapman Road is being reconstructed. As part of the reconstruction of this road, the construction of curb and gutter is proposed on both sides of the section of Chapman Road between west of Scarlett Road and west of Easthampton Drive, resulting in a narrowing of the road to 8 metres. The highway alterations related to this section of Chapman Road are shown on the attached drawing and described in Appendix "A".

COMMENTS

Chapman Road is a local residential road that extends between Scarlett Road and Royal York Road, north of Eglinton Avenue West. The road currently has a rural cross-section (i.e. ditches and swales) and there are sidewalks on both sides. As part of the reconstruction of Chapman Road, curb and gutter will be constructed on the section of road between west of Scarlett Road to west of Easthampton Drive. As a result of the proposed curb and gutter, the road width will be narrowed to 8 metres.

The authorization of the road alteration to the City of Toronto Act, 2006, will mitigate the City's legal liability as the road authority. Therefore, it is recommended that Community Council authorize this road alteration.
