**Re: Queen's Plate Liquor Licence Extension July 3, 2016**

Please be advised that we are presently requesting a Temporary Extension Liquor Sales Licence for our outdoor Walking Ring area, West Parking Lot adjacent to the Walking Ring, our Standardbred Paddock Building and the Parking Lot area north of our existing Track Side Tent here at Woodbine Race Track.

Similar to our granted extension on July 5<sup>th</sup> of 2015 with the addition of the Paddock Building and the surrounding parking lot space, attached you will find the diagram of the requested area directly adjacent to our existing licence. This area will be segregated by way of a temporary 42 inch metal fence ( shown in red on diagram ) attached to our existing licensed area. This area will start at the east end of the building, running along the perimeter of the Walking Ring Area including the Standardbred Paddock and parking lot and again attaching itself to our existing licensed area on the west end of the building. The area will include up to five temporary tents, 40 ft. by 100 ft. ( tent supplier to obtain permits), portable washroom facilities, food truck(s) and two outdoor entertainment stages. The smaller of the two stages will be set up in the Walking Ring area and the main concert stage will be in the west parking lot. We expect an approximate attendance in this extended area of 25,000 people. Each access point will be manned by a Smart Serve Certified door host.

The event will run from 11:00am to 11:00pm for one day only on July 3<sup>th</sup>, 2016.

As per Liquor Board regulations, we require a letter of "no objection" to the extension of our proposed extended licensed area from the Municipal Clerk's Office.
