Main Location – 2445 Lake Shore Blvd West

<u>Business Hours and Building Utilization</u>: The building is utilized during the weekdays, evenings and on weekends to run programs and services for seniors and seniors with disabilities. In addition, this building is also occupied (i.e., space is rented out) by the local community groups for community engagements, meetings etc.

New Addition to the Front (North Side): To further enhance the quality of service delivery and

to better sustain our commitment to delivering service excellence, the Additional Space to the

front of the building has now been completed. It is open to seniors as a seniors drop in and is

planned to be used to accommodate blend of the activities on scheduled days and times to

help avoid overlapping.

✤ ELDERLY PERSONS CENTRE

- The Elderly Persons Centre provides a variety of services to seniors and seniors with disabilities in South Etobicoke. The programs and activities offer clients with a way of life in which physical, social, mental and emotional activities are valued and integrated into daily living.
- Social recreation activities are coordinated and provided to seniors and adults with disabilities through this program focusing on wellness, health promotion, and illness prevention.
- The program is run in cooperation with a paid trained coordinator, volunteers and the clients of the program.

Program Activities: The activities assist to increase identification and utilization of other programs, provides outreach, support the independent living, promote healthy habits & lifestyle, promote a basket of services, assist in locating, linking and arranging services such as organizing, linkages to services offered in the community.

Credible Organization & Growing

Qualified, Trained & Experienced Work Force

- Serving the Community since 1971, Storefront Humber has flourished to thriving 160-165 employees (out of which 80-85are FTE's includes administrative, community and Supportive Housing both full-time and part-time staff).
- We have a **membership** base of hundreds of clients who attend our AGM and use their voting rights.
- Provide services to over 3,200 clients annually.
- In addition, the agency's first funding came from "Comsoc" the Ministry of Social Services and at that time the budget was \$350,000 to current operating budget of over **5.4 million** in 2015.
- We are well connected with the communities, service providers and funders.
