SUMMARY

The purpose of this report is to provide a summary of the City's employer contributions submitted to OMERS over the last five years and to provide information of the City's total members and contributions relative to the overall OMERS plan members and contributions.

RECOMMENDATIONS

The Treasurer recommends that:

DECISION HISTORY

Government Management Committee at its meeting on January 4, 2016 requested the City Manager and the Treasurer to report to the Government Management Committee on February 22, 2016, and in the future on an annual basis, on OMERS as it relates to the City's Employer Contributions (GM9.16).

ISSUE BACKGROUND

The City of Toronto is a participating employer of the OMERS Primary Pension Plan and, as such, is subject to the OMERS regulations and the requirements under the *Pension Benefits Act of Ontario*.

As at December 31, 2015, the City has 26,413 active OMERS members of which 21,096 employees were permanent full-time and 5,317 were temporary/part-time employees.

The OMERS primary pension plan provides benefits under two plans:

- 1. Normal Retirement Age (NRA) 65 Non-fire-fighters; and
- 2. Normal Retirement Age (NRA) 60 Fire-fighters

Of the 26,413 total active OMERS membership, 23,333 employees are enrolled in the NRA 65 plan and 3,080 employees are enrolled in the NRA 60 plan (all Fire fighters).

Attachment 1 provides the total City OMERS Membership including permanent and temporary/part-time employees for that last six years.

The current contribution rates for each of the plans are provided in table 1 below:

Attachment 2 provides a summary of the contribution rates for the last six years, 2010 to 2015.

In 2015 the City submitted total contributions of \$384.7 million, of which \$192.4 million were employer contributions and an equal amount of \$192.4 million were employee contributions.

Attachment 3 provides a summary of the total contributions submitted by the City over the last six years, 2010 to 2015.

COMMENTS

On June 30, 2006, the *Ontario Municipal Employees Retirement System Act, 2006* (the OMERS Act), changed to an independent dual governance bicameral model, replacing the Province as Sponsor of the Plan with the OMERS Sponsors Corporation (SC) and continuing the role of the OMERS Administration Corporation (OAC) as the Administrator/Fiduciary.

Board Composition

The OMERS SC has 14 members (which includes 2 Co-Chairs) made up of equal numbers of employee and employer representatives. Members are appointed by their sponsoring organizations for a three year term. The Board is headed by two Co-Chairs (one appointed by employee representatives and the other appointed by employer representatives). The OMERS SC determines the composition of both the OMERS SC and the OAC. The City of Toronto has one employer representative (currently Joe Pennachetti) and one employee representative (currently Tim Maguire).

The OAC has 14 members nominated by OMERS employer sponsors and appointed by OMERS SC, plus an independent Board Chair appointed by the OMERS SC, for a total of 15 members. The City of Toronto has one representative on the OAC (currently David Beatty).

OMERS Sponsors Corporation Board: City of Toronto Representative

The City appoints one (1) representative to the OMERS SC. At its meeting on June 19, 20 and 22, 2007, City Council delegated authority to the City Manager to appoint the City representative with the adoption of the following motion (re: CC10.2 "Appointment of OMERS Sponsors Corporation Board"):

1. The City Manager be delegated the authority to identify and appoint a candidate who meets the required competencies to serve at the pleasure of the City on the OMERS Sponsors Corporation board as the City of Toronto Employer Member for a term of office commencing June 30, 2007, and ending June 30, 2010. 2. The City Manager be granted this delegated authority on an ongoing basis for future appointments to the board, noting that Council may remove the City's appointee at any time upon written notice to that member and the Co-Chairs of the board.

In October 2015, the City Manager appointed Mr. Joseph Pennachetti as the City's representative on the OMERS SC for a three year term commencing on January 1, 2016.

OMERS Administration Corporation Board: City of Toronto Representative

The City appoints one (1) representative to the OAC. At its meeting on December 1, 2 and 3, 2008, City Council delegated authority to the City Manager to appoint the City representative with adoption of the following motion (re: EX26.8 "Appointment of OMERS Administration Corporation Board"):

- 1. City Council reappoint Cameron Weldon to the Administration Corporation for a term of three years, subject to Section 33 of the OMERS Act, 2006.
- 2. The City Manager be delegated the authority to identify and appoint a candidate who meets the required competencies on an ongoing basis for future appointments to the board, noting that Council may remove the City's appointee at any time upon written notice to that member and the Chair of the Board.

In April 2015, the City Manager re-appointed Mr. David Beatty as City's representative on the OMERS Administrative Corporation Board for a 2nd three-year term commencing on January 1, 2016.

Generally speaking, the SC is responsible for the overall plan design and setting of contribution rates while the OAC is responsible for pension administration, investment strategy, investments and preparation of the Plan Valuation. A more detailed overview is provided in Attachment 5.

Overview of Overall OMERS Membership and Contributions

OMERS provides defined pension benefits to local government employees, retirees and beneficiaries throughout Ontario. The OMERS Primary Pension Plan is a jointly sponsored, multi-employer pension plan with approximately 1,000 participating employers in 2014, and approximately 268,000 active primary plan members in 2014.

Employers range from large cities, to numerous local agencies. Primary Plan members include union and non-union municipal workers; police, firefighters and paramedics; the non-teaching staff of school boards; and employees of children's aid societies, transit systems and electrical utilities.

The City of Toronto is the largest OMERS employer and represents a significant portion of the overall OMERS membership, approximately 9%, and the overall contributions paid to OMERS, approximately 10.5%.

In addition, as outlined in Attachment 4, many of the City's agencies and corporations are also OMERS employers. As at December 31, 2014, the City's agencies and corporations had 13,580 active OMERS members and represented 5% of the overall OMERS membership. Further, the approximate contributions for the City's agencies and corporations are \$126.9 million which represents approximately 7.1% of the overall contributions.

When these agencies and corporations are included, the City represents approximately 14% of the OMERS membership and approximately 17.6% of the total contributions submitted.




