PURPOSE OF THE APPLICATION:

To construct a new two-storey dwelling with an integral garage. The existing dwelling would be demolished.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

- 1. Chapter 10.20.40.40.(1), By-law No. 569-2013 The maximum permitted floor space index is 0.35 times the lot area. The proposed floor space index is 0.69 times the lot area.
- 2. Section 6(3) Part I 1, By-law No. 438-86 The maximum permitted gross floor area is 0.35 times the lot area. The proposed gross floor area is 0.69 times the lot area.
- Section 6(3), Part IV 3(II), By-law No. 438-86 The by-law does not permit an integral garage in a building where the floor level of the garage is located below grade. The proposed integral garage is below grade.
