Notice was given and a Public Hearing was held on Thursday, November 3, 2016, as required by the Planning Act.

PURPOSE OF THE APPLICATION:

The applicant is seeking relief from the provisions of the Zoning By-law to use the existing structure for a place of worship for a temporary period of 3 years during the construction of the temple located at 733 Birchmount Road.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

By-law No. 569-2013

- To permit a 518.4 square metres place of worship, whereas the Zoning By-law does not permit place of 1. worship in the E zone.
- To permit 94 parking spaces, whereas the Zoning By-law requires a minimum total of 153 parking spaces 2. (139 spaces for place of worship use, 9 spaces for warehouse use, and 5 spaces for office use).

By-law No 24982

To permit a place of worship, whereas the Zoning By-law permits places of worship as a sole use on a lot. 3.
