Subject: **Authorization to Study Lawrence Park West as a Potential Heritage Conservation District**

Recommendations:

The Toronto Preservation Board recommends to the North York Community Council that:

1. City Council authorize that a study be undertaken of the Lawrence Park West Area as potential Heritage Conservation District under Section 40(1) of the Ontario Heritage Act, as indicated by the boundary in Attachment 1 of the report (August 9, 2016) from the Chief Planner and Executive Director, City Planning Division.
2. City Council authorize a study of Lawrence Park East as a potential Heritage Conservation District.
3. City Council request the Senior Manager, Heritage Preservation Services to expedite staff review of all properties nominated for inclusion on the City's Heritage Register within the Lawrence Park West Study Area boundary including the following:

35 St. Edmund's Drive
24 Dinnick Crescent
40 St. Leonard's Avenue
50 Dawlish Avenue
110 Dawlish Avenue


