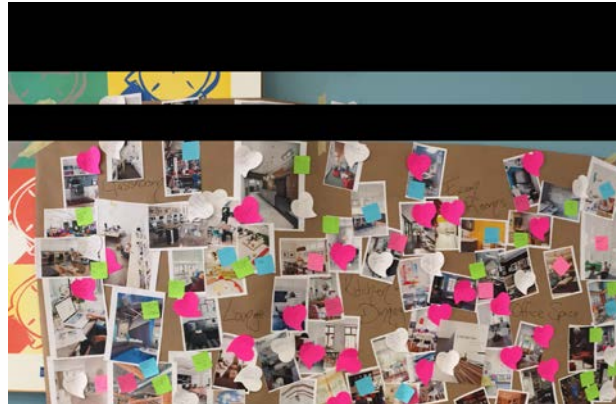

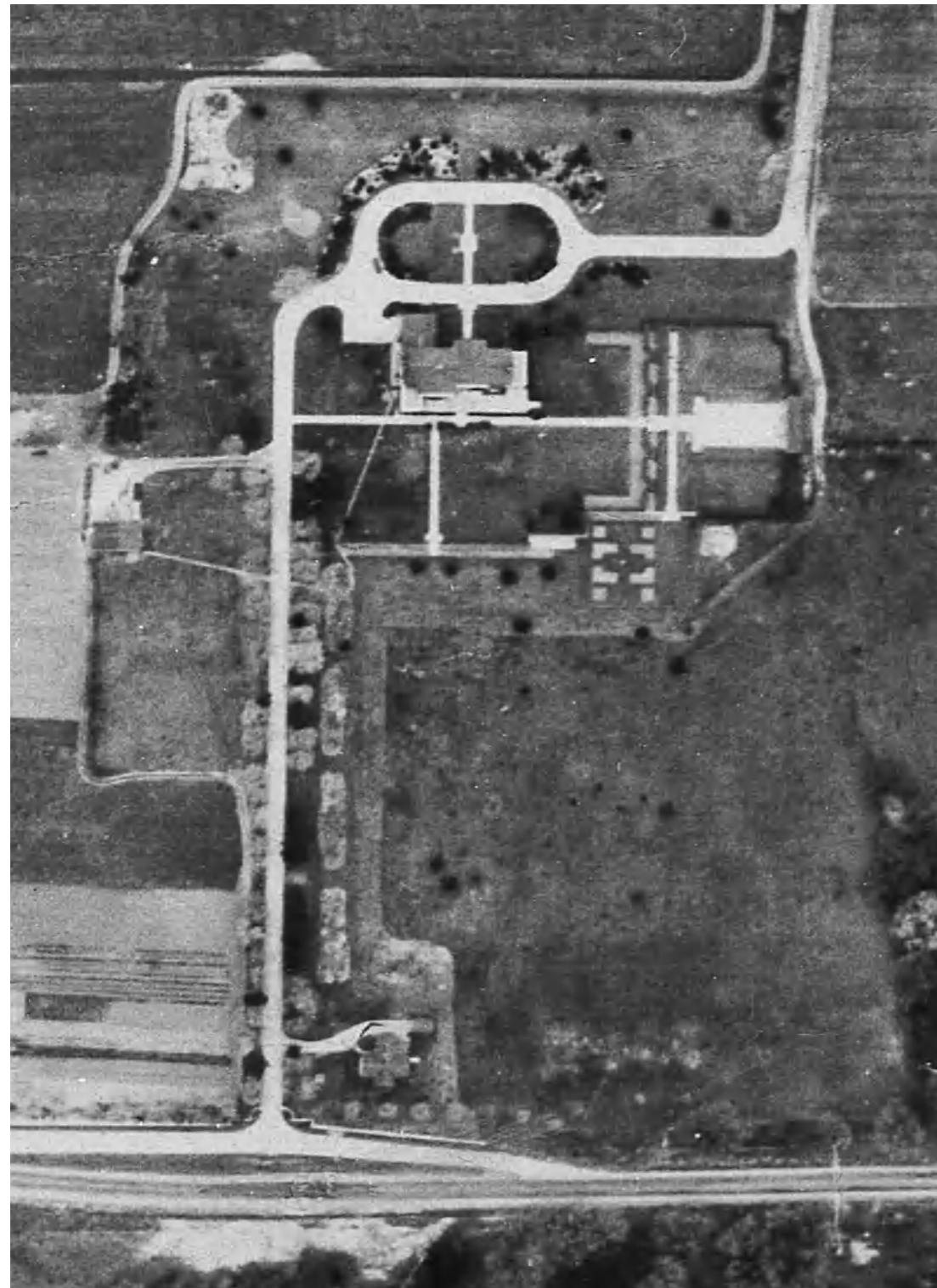


SITE HISTORY

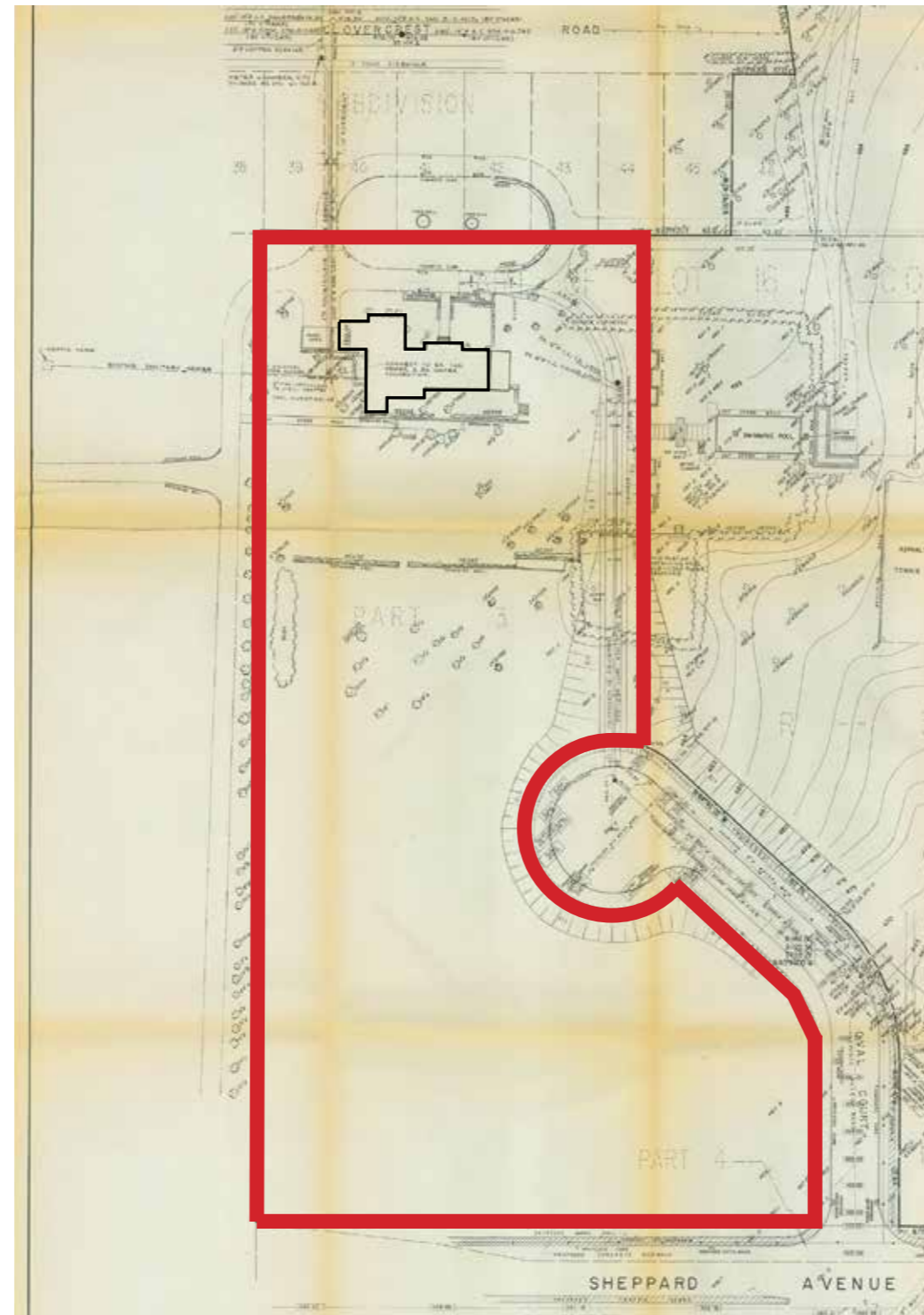
- **1936:** Frederick Martin Connell purchased 300 acre property

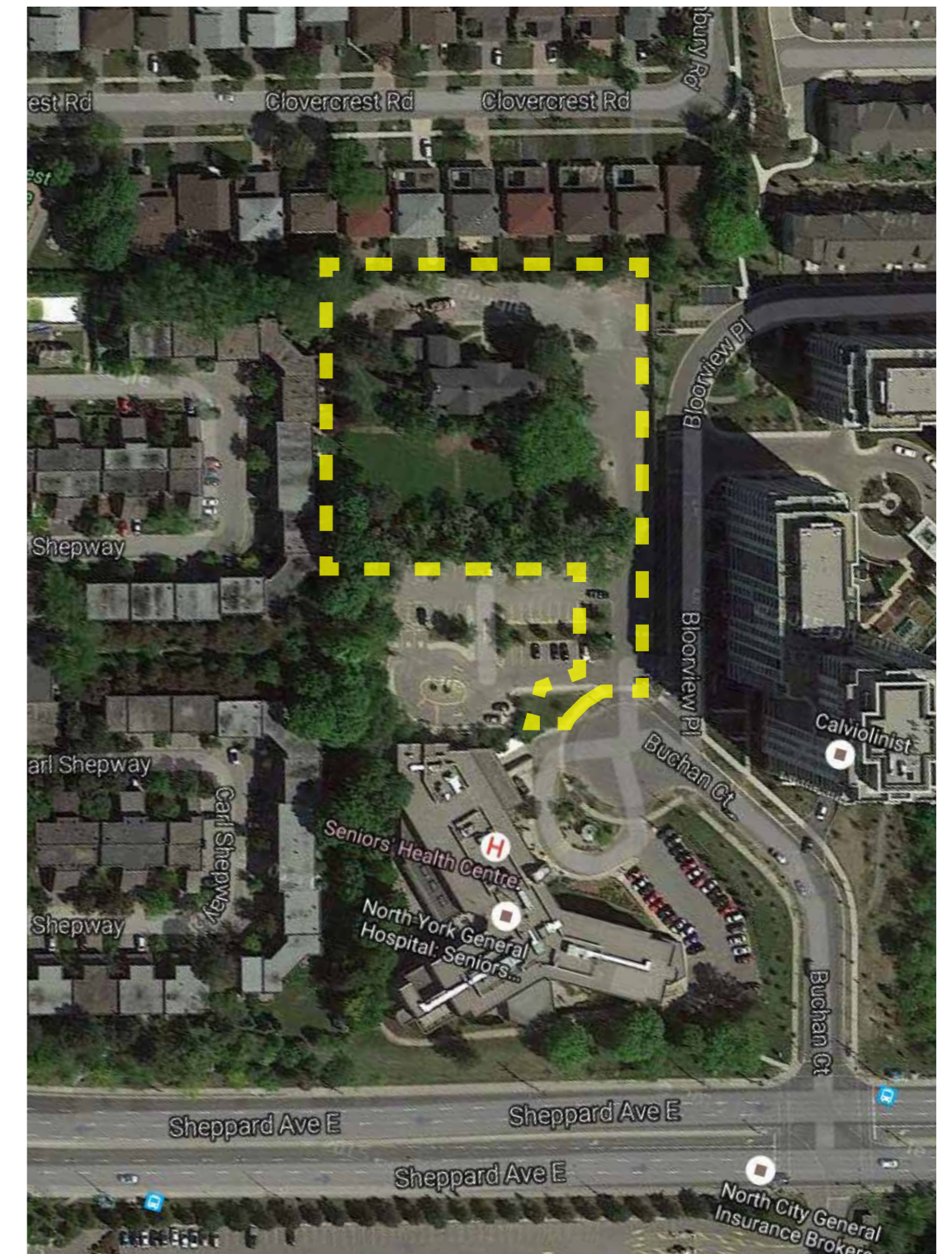
