Dear Chair Shiner and Committee members,

Please note GBNA's (profile below) strong support for the recommendations made by the Confederation of Resident and Ratepayer Associations in Toronto (CORRA) with respect to item PG9.8 on the agenda for the above meeting. In particular that:

- 1. Council direct City staff to reinforce the intent of Zoning By-Law 569-2013 provisions by stating in the Mid-Rise Building Performance Standards that habitable space is discouraged above the maximum allowable building height.
- 2. City Council direct that Performance Standard #1 of the Mid-Rise Buildings Performance Standards be amended by:
- a. including a 0.8:1 ratio (or 16 metre height limit) in Character Areas as defined in the Avenues and Character Area Map, as revised, which have 20m right-of-ways, as shown on Map (3) of the Official Plan, excluding areas that have a local planning study that speaks to different heights, or existing zoning permission that exceeds 16m;
- b. including a 0.8:1 ratio (or 21.6 metre height limit) in Bloor West Village, defined as the stretch of Bloor Street between Jane Street and Clendenan Avenue;
