## Public Notice

## Amendments to City of Toronto Municipal Code Chapter 441, User Fee Policy and Toronto Municipal Code Chapter 743, Streets and Sidewalks.

At its meeting in Committee Room 1, 2nd Floor, Toronto City Hall, 100 Queen Street West, Toronto, on Monday, November 21, 2016, the Public Works and Infrastructure Committee will consider Item PW17.7, which contains a recommendation which may result in amendments to City of Toronto Municipal Code Chapter 441, User Fee Policy and Toronto Municipal Code Chapter 743, Streets and Sidewalks.

It is proposed that the by-law(s) be adopted at the Council meeting to be held on December 13, 2016 or at a subsequent meeting.

The report (November 3, 2016) from the Acting General Manager, Transportation Services, titled "Use of Pavers on City Streets" has the following recommendation:

1. City Council amend City of Toronto Municipal Code Chapter 441, Fees and Charges to add the following new user fees for 2017 where third parties replace concrete or asphalt with pavers in the City's right-of-way to cover the costs of long-term maintenance, subject to the annual inflation rate:

a) One-time Paver Maintenance Fee - \$55 sq. metre of paving installed plus all applicable taxes

b) An additional percentage of up to 15% of the above fee for complex designs based upon recommendations as outlined in this report

This report recommends adding a user fee such that any third party who replaces concrete or asphalt with City Standard pavers will pay to cover the costs of ongoing maintenance to those pavers.

If approved by City Council, City of Toronto Municipal Code Chapter 441, User Fee Policy and Toronto Municipal Code Chapter 743, Streets and Sidewalks will require amendment.
