Naming of Proposed Private Lane at 3765 St. Clair Avenue East

SUMMARY

This report recommends that the name "Water Willow Lane" be approved to identify a proposed private lane at 3765 St. Clair Avenue East.

Community Councils have delegated authority to decide street naming matters, which comply with the City of Toronto Street Naming Policy.

RECOMMENDATIONS

Engineering & Construction Services recommends the following:

1. Scarborough Community Council approve the name "Water Willow Lane", to identify a proposed private lane at 3765 St. Clair Avenue East;
2. the applicant pay the costs, estimated to be \$300.00, for the fabrication and installation of a street name sign; and
3. the owner and successors of the subject lands maintain, at their own risk, the signage installed under Recommendations (2).

Financial Impact

There are no financial implications for the City resulting from the adoption of this report.

ISSUE BACKGROUND

An application was made by Malone Given Parsons Ltd, to name a proposed private lane located within a development at 3765 St. Clair Avenue East. The proposed name "Water Willow" is derived from the American Water-Willow, an aquatic perennial plant that grows in Ontario.

The proposed private lane is identified as Part 1 on Attachment No.1 Sketch No. PS-2016-042.

COMMENTS

The proposed name has been circulated for comment and is acceptable to Toronto Police Service, Toronto Fire Services, and Toronto Paramedic Services.

Councillor Crawford supports the name.

This naming proposal complies with the City of Toronto Street Naming Policy.

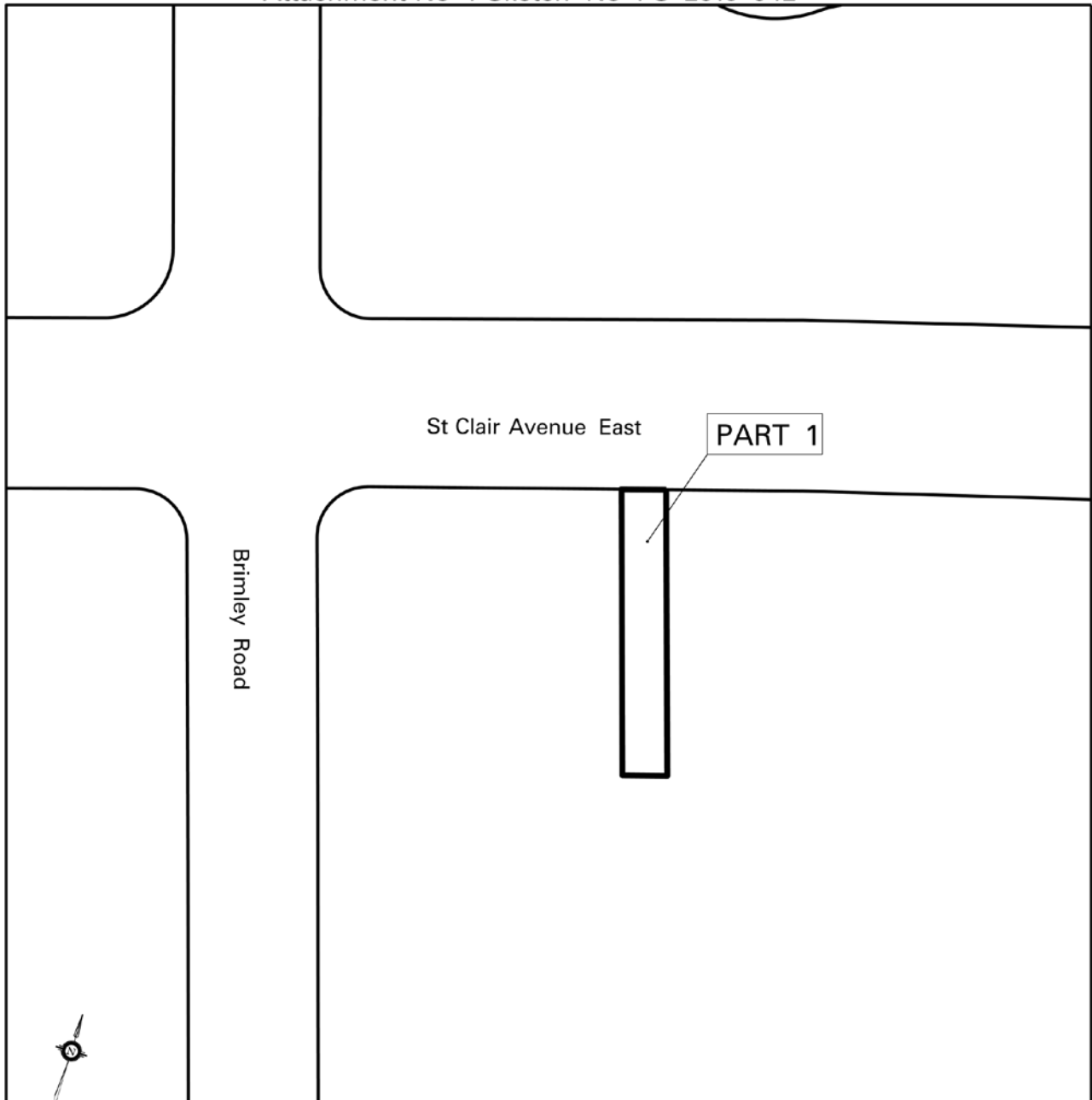
