

Realignment of Permit Parking Area 1A to exclude the addresses of 299 Campbell Avenue

SUMMARY

Transportation Services is requesting approval from City Council to amend the boundary of permit parking area 1A.

Transportation Services has assessed the realignment of permit parking area 1A to exclude the property located at 299 Campbell Avenue as requested by Toronto and East York Community Council on October 13, 2016. We are recommending approval of the realignment as it will not impact negatively on the permit parking area.

RECOMMENDATIONS

The manager, Transportation Services, Right of Way Management, Toronto and East York District recommends that:

1. City Council approve the amendment to Schedule B of the City of Toronto Municipal Code, Chapter 925, Permit Parking, to incorporate a revised map of permit parking area "1A", as attached in Appendix A of the report (October 13, 2016) from the Manager, Right or Way Management, Transportation Services, Toronto and East York District.

FINANCIAL IMPACT

There is no financial impact associated with this report.

DECISION HISTORY

At its meeting October 13, 2016 Toronto and East York Community Council in considering item TE19.79, requested Transportation Services to examine and report back to Toronto and East York Community Council regarding the realignment of permit parking area 1A and the exclusion of the subject site at 299 Campbell Avenue

COMMENTS

Permit Parking area 1A is bounded on the west by the CN rail line, on the east by the Eastern CN rail line, on the south by Bloor Street West and on the north by the CP rail line. Area 1A has 909 on-street parking spaces. To date, 595 permits have been issued. This area does not have a history of being waitlisted meaning the demand for overnight on-street parking permits has never exceeded the supply of parking spaces. There is no TTC service on Campbell Avenue. Councillor Bailao and residents neighbouring 299 Campbell Avenue support this action as a means of ensuring that this new development does not negatively impact the permit parking supply to the existing neighbourhood.

Transportation Services has no objections to the exclusion of 299 Campbell Avenue from permit parking area 1A
