10 St. Mary Street - OMB Appeal - Request for Direction

REASON FOR CONFIDENTIAL INFORMATION

This report contains advice or communications that are subject to solicitor-client privilege.

SUMMARY

An application was submitted to amend the Zoning By-law for the lands at 10 St. Mary Street and to demolish an 8-storey designated heritage office building on the site in order to construct a 42-storey mixed-use building with 255 residential dwelling units and 251 square metres of ground floor retail. The application was appealed to the Ontario Municipal Board (OMB) for Council's failure to make a decision on the application within the prescribed timelines in the *Planning Act*, and a hearing was scheduled to commence on November 1, 2016.

On May 3, 2016, the City received a without prejudice settlement offer from the applicant. At its meeting on June 7, 8 & 9, 2016, Council refused the settlement offer and refused the demolition permit application. The owner appealed Council's decision to refuse the demolition permit application to the OMB and this appeal has been consolidated with the Zoning By-law appeal.

The November 1, 2016 hearing was adjourned and a pre-hearing has been scheduled for May 24, 2017. The City Solicitor seeks further direction on this matter no later than the completion of the City Council meeting on March 9, 2017.

RECOMMENDATIONS

The City Solicitor recommends that:

- 1. City Council adopt the confidential recommendations in Confidential Attachment 1.
- 2. If the City Solicitor's confidential recommendations are adopted by Council, then City Council authorize the public release of:
 - a. the recommendations contained in Confidential Attachment 1 (with the remainder of Confidential Attachment 1 to remain confidential as it contains information that is subject to solicitor-client privilege),
 - b. all of Confidential Attachment 2, and
 - c. all of Confidential Attachment 3.

FINANCIAL IMPACT

There is no financial impact arising from the adoption of the confidential recommendation.

DECISION HISTORY

On October 8, 9, 10 & 11, 2013, City Council adopted Official Plan Amendment 183 – North Downtown Yonge Site and Area Specific Policy and Draft North Downtown Yonge Urban Design Guidelines, which identified the property at 10 St. Mary Street as having potential heritage value.
