Further to my email below, I am writing to follow up again on behalf of our client, Islamic Community of Afghans in Canada (Appeal #105).

As previously advised, our client – and the community it represents – are of limited financial means. When they instructed us to file this appeal, it was in the hope and expectation that the City would act in a manner consistent with the recent OMB approved settlement respecting their site redevelopment plans (attached), and confirm support for the site and area specific policy they are seeking as part of OPA 231.

Unfortunately, unless we can resolve this in short order we will no longer be able to continue acting for our client and expect it will have to carry the appeal forward on a self-represented basis. Frankly, we do not consider that to be in anyone's interest.

Can I ask you once again to consider our client's request for a SASP (attached) and let us know if you and Staff are prepared to support it before the Board, as soon as possible.

Proposed Site and Area Specific Policy for inclusion into City of Toronto By-law No. 1714-2031 being a By-law to adopt Amendment No. 231 to the Official Plan of the City of Toronto

Chapter 7, Site and Area Policies, is amended by adding Site and Area Specific Policy No. **XXX** for the lands known municipally in 2012 as 88 Sunrise Avenue and 22 Hobson Avenue, as follows:

“XXX 88 Sunrise Avenue and 22 Hobson Avenue

- a) Place of worship and ancillary community centre uses are permitted.'
