SUMMARY

An application was submitted to amend the Zoning By-law for the lands at 2619 Bayview Avenue and 6 Heathcote Avenue (formerly known as 2617 Bayview Avenue) to permit the construction of six three-storey townhouse units and one two-storey single family detached dwelling. The application was appealed to the Ontario Municipal Board (OMB) for Council's failure to make a decision on the application within the prescribed timelines in the *Planning Act*. A hearing date has not yet been scheduled at the OMB.

The City Solicitor seeks direction on this matter no later than the completion of the City Council meeting on March 28, 2017.

RECOMMENDATIONS

The City Solicitor recommends that:

1. City Council adopt the confidential recommendations in Confidential Attachment 1.

2. If the City Solicitor's confidential recommendations are adopted by Council, then City Council authorize the public release of the recommendations contained in Confidential 2619 Bayview Avenue and 6 Heathcote Avenue (Formerly known as 2617 Bayview Avenue) - OMB Appeal - Request for Direction
