SUMMARY

On March 7, 2017 Executive Committee considered the report [EX23.1 Next Steps on the Scarborough Subway Extension](#) (SSE). Executive Committee requested the City Manager, in consultation with the Chief Executive Officer, Toronto Transit Commission (TTC) to report directly to City Council with the following:

- a list and map of the 42 permanent property requirements identified for the recommended McCowan alignment for the SSE; and
- the names and a map of the 34 bus routes that would use the proposed Triton bus terminal.

The requested information is included in Attachment 1 and Attachment 2 of this report.
