City of Toronto Act, 2006 Public Notice

Notice is given that the Chief Building Official and Executive Director, Toronto Building, is reporting on a proposal which seeks to amend Chapter 694, Signs, General, of the City of Toronto Municipal Code.

This report proposes amendments to the provisions of Chapter 694 to: Establish updated regulations applicable to the Dundas Square Special Sign Districts, in order to allow for the erection and display of 7 signs at 1 Dundas Street East as follows:

- One Electronic ground sign containing: two sign faces displaying static copy; and, four sign faces displaying electronic moving copy.
 - The portion of the sign displaying static copy is limited to the identification of Yonge-Dundas Square.
 - The portion of the sign displaying electronic moving copy is to display third party advertising.
 - The sign face area displaying static copy will be 19.8 square metres.
 - The sign face area displaying electronic moving copy will have a sign face area of 34 square metres.
 - The sign height will be 15.2 metres.
- One Electronic roof sign containing one sign face displaying electronic moving copy. The sign will display programming associated with performances and events at the Square, display of visitor information, event sponsorship, third-party advertising, public art and video projects.
 - The proposed sign face area will be 18 square metres.
 - The sign height will be 10.7 metres above grade.
- One Electronic roof sign containing: one sign face displaying static copy and one sign face displaying electronic moving copy.
 - The portion of the sign displaying static copy is limited to the identification of Yonge-Dundas Square.
 - The portion of the sign displaying electronic moving copy is to display third party advertising.
 - The sign face area displaying static copy will be 6.7 square metres.
 - The sign face area displaying electronic moving copy will be 15.2 square metres.
 - The sign height will be 10.9 metres.
- Three Electronic ground signs containing one sign face displaying electronic moving copy. The sign will display programming associated with performances and events at the Square, display of visitor information, event sponsorship, third-party advertising, public art and video projects.
 - The sign face area(s) will be 10.4 square metres.

- The sign height for each sign will be 18.3 metres.
- One Electronic ground sign containing one sign face displaying electronic moving copy. The sign will display programming associated with performances and events at the Square, display of visitor information, event sponsorship, third-party advertising, public art and video projects.
 - The proposed sign face area is 18.30 square metres.
 - The sign height will be 10.4 metres.

The Chief Building Official and Executive Director, Toronto Building is recommending that the Council of the City of Toronto amend Chapter 694, Signs, General, of the City of Toronto Municipal Code, in the manner proposed above.

At its meeting to be held in Committee Room 1, Toronto City Hall on January 19, 2017, at 9:30 a.m. or as soon as possible thereafter, the Executive Committee of Toronto City Council will hear in person, or by his or her counsel, agent or solicitor, any person who wishes to speak to the matter.
