PURPOSE OF THE APPLICATION:

To construct a new detached dwelling with an integral garage.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

1. Section 10.20.40.20.(1), By-law 569-2013

The maximum permitted dwelling length is 17 m. The proposed dwelling will have a length of 22.28 m.

2. Section 10.20.40.30.(1), By-law 569-2013

The maximum permitted dwelling depth is 19 m.

Section 320-42.1.D.(1)

The maximum permitted dwelling depth is 16.5 m.

Section 10.20.40.30.(1), By-law 569-2013 and Section 320-42.1.D.(1)

The proposed dwelling will have a depth of 26.59 m.

THE COMMITTEE OF ADJUSTMENT & MINOR VARIANCES

The role of the Committee of Adjustment is to provide flexibility in dealing with minor adjustments to zoning bylaw requirements. To approve such variances, the Committee must be satisfied that:

- the variance requested is minor;
- the proposal is desirable for the appropriate development or use of the land and/or building;
- the general intent and purpose of the City's Zoning Code and/or By-law are maintained; and
- the general intent and purpose of the Official Plan are maintained.

The Committee of Adjustment forms its opinion through its detailed review of all material filed with an application, letters received, deputations made at the public hearing and results of site inspections.

MAKING YOUR VIEWS KNOWN

The notice has been mailed to you, as required by the *Planning Act*, to ensure that, as an interested person, you may make your views known by:

- Attending the Public Hearing. Attendant Care Services can be made available with some advance notice.
- Sending a letter by Mail, E-mail, or Fax. Information you choose to disclose in your correspondence will be used to receive your views on the relevant issue(s) to enable the Committee to make its decision on this matter. This information will become part of the public record.

If you do not attend the public hearing, or express your views in writing, the Committee may make a decision in your absence, and may recommend changes to the proposal
