

City of Toronto Act, 2006 Public Notice

**Changes to the On-Street Paid Parking Rates and Hours of Operation  
Chapter 910, Parking Machines and Meters and  
Changes to Chapter 179, Parking Authority**

**Toronto City Council will be considering recommendations to pass by-laws to amend the City of Toronto Municipal Code Chapter 910, Parking Machines and Meters, so as to incorporate changes to the paid parking rates and hours of operation and to amend City of Toronto Municipal Code Chapter 179, Parking Authority to adjust the Parking Authority's delegated authority.**

It is proposed that the by-laws be adopted at the City Council meeting to be held on October 2, 2017 or at a subsequent meeting.

The proposed changes are detailed in the report titled, Changes to the On-Street Paid Parking Rates and Hours of Operation [Changes to the On-Street Paid Parking Rates and Hours of Operation](#)

The proposed changes to Subsection 179-7D of the City of Toronto Municipal Code, Chapter 179, Parking Authority, are to adjust the Parking Authority's delegated authority to fix rates for on-street parking metres or parking machines from the existing upper limit of \$4.00 (inclusive of HST) per hour to \$5.00 (inclusive of HST) per hour.

At its meeting to be held in Committee Room 2, Toronto City Hall on September 25, 2017, at 9:30 a.m. or as soon as possible thereafter, the Government Management Committee of Toronto City Council will hear in person, or by his or her counsel, agent or solicitor, any person who wishes to speak to the matter.
