Dear Mr. Macrae,

The Toronto District School Board (TDSB) owns and operates the John Fisher Junior Public School located on 40 Erskine Avenue. The KG Group has submitted a site plan for approval to the City of Toronto to build a 33-storey apartment tower on 18-30 Erskine Avenue, next to John Fisher Junior Public School.

The TDSB is concerned about the impact a development of this nature will have on the safe and uninterrupted operation of the school and the well-being of its occupants.

We are writing to provide formal written notification to the City and the KG Group that we want to review all documents pertaining to this development, in particular the Construction Management Plan.

In the near future, the TDSB will be sending a list of expectations that it wants considered during the City staff review of this project, as the safety and security of our staff, students and the school community is of paramount importance to the TDSB. In addition, the TDSB requests that (i) City staff consult with TDSB staff before finalizing and approving the Construction Management Plan; and (ii) the TDSB is given sufficient and appropriate written notice, by the City and the KG Group, before the commencement of any construction activities, in order to allow the TDSB the required time to make appropriate arrangements to accommodate the needs of the students, parents and staff at the school.

Your immediate attention and response to this letter is greatly appreciated.
