### PROPOSAL

The application to amend the (former City of Scarborough) Scarborough Village Community Zoning By-law No. 10010, as amended, will have the effect of placing a Holding (H) provision on portions of the property located at 3201 to 3227 Eglinton Avenue East. The Holding provision will restrict development from proceeding until such time as site specific matters are addressed such as servicing, transportation operations and land conveyances.

This land is also subject to an application under the Planning Act for an extension of the existing conditional approval of draft plan of subdivision, Application No. 07 272331 ESC SB.

**If you wish to be notified** of the decision of the City of Toronto on the passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk, attention: Yvonne Davies, Administrator, Scarborough Community Council, at the address, fax number or e-mail set out in this notice.

**Zoning By-law Amendments Appeal:** If a person or public body does not make oral submissions at a public meeting or make written submissions to the City Clerk, attention: Yvonne Davies, Administrator, Scarborough Community Council, at the address, fax number or e-mail set out in this notice before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision to the Ontario Municipal Board and may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

**People writing or making presentations at the public meeting:** The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.
