

Temporary Adjustments to Traffic/Parking Regulations for 2017 Canadian National Exhibition - (Non-Delegated)

SUMMARY

The purpose of this report is to seek City Council's authority to enact temporary traffic and parking amendments required to enhance traffic operations and pedestrian safety during the annual Canadian National Exhibition (CNE), which takes place from August 18 to September 4, 2017, inclusive. As this staff report concerns roadways with regular TTC service, City Council approval is required.

RECOMMENDATIONS

The Director, Transportation Services Division, Toronto and East York District, recommends that:

1. City Council authorize the temporary traffic and parking regulations on streets in the vicinity of Exhibition Place that are impacted during the Canadian National Exhibition, identified in Appendix "A" attached to the report dated April 28, 2017 from the Acting Director, Transportation Services, Toronto and East York District.

FINANCIAL IMPACT

Funds in the amount of \$4,000.00 are available within the Transportation Services Division's 2017 Operating Budget. Parking meter/machine revenue, estimated to be approximately \$28,000.00, will be lost as a result of parking prohibitions required on Dufferin Street during the CNE.

DECISION HISTORY

Annually, the Transportation Services Division receives Community and City Council authority to implement a number of temporary traffic and parking regulations on various streets in the vicinity of Exhibition Place that are impacted by the CNE.

COMMENTS

Having regard for the high volume of vehicular and pedestrian traffic generated during the CNE, the temporary traffic and parking regulations as shown in the attached Appendix "A" will help maintain efficient traffic conditions in the general area of the CNE while recognizing the impacts on local residents. The streets listed in Appendix "A" do have regular TTC routes. It is noted that a companion report is also submitted relating to temporary parking adjustments for the 2017 CNE for streets not served by transit routes. Approval of those adjustments is delegated to Community Council.

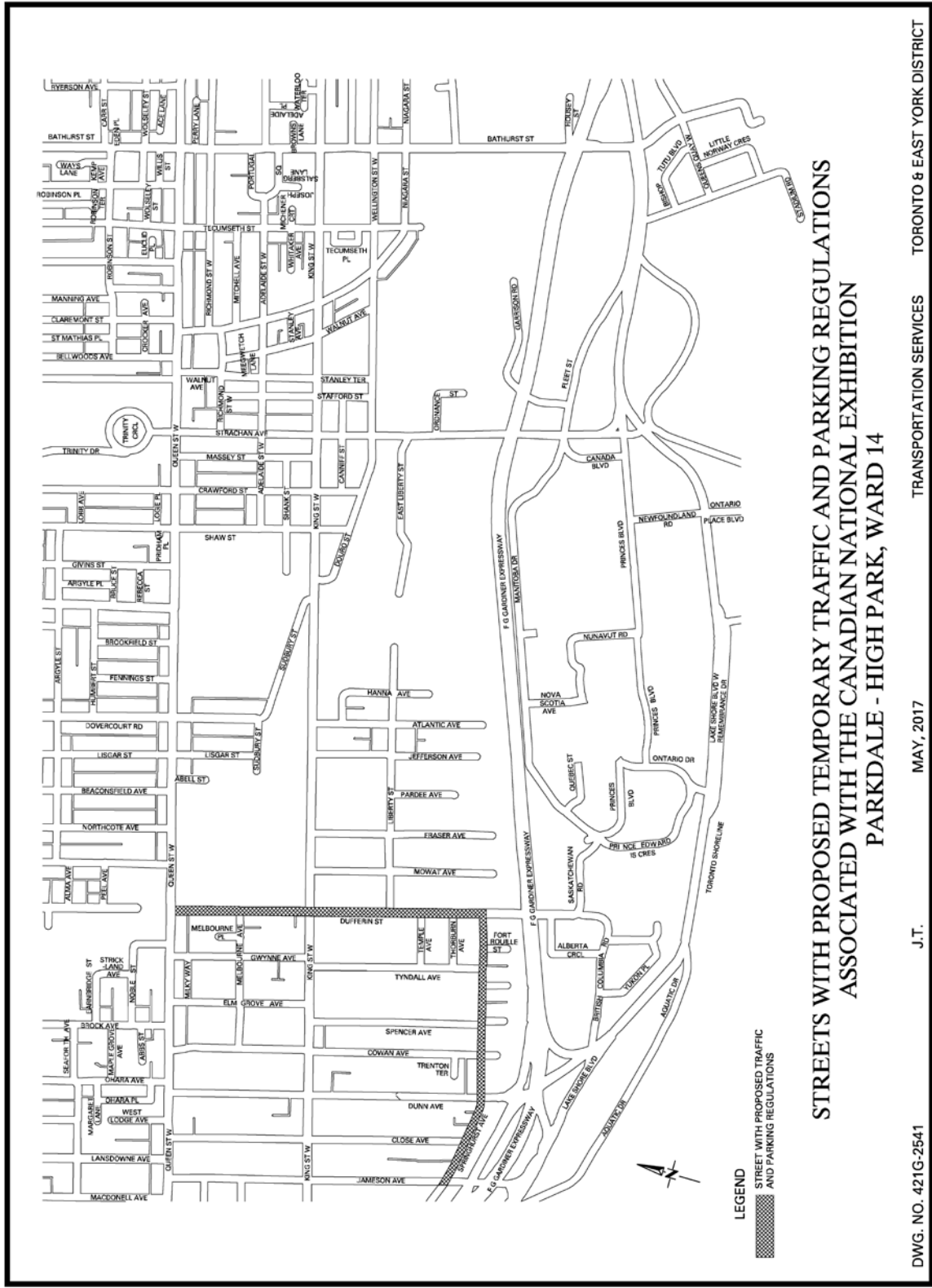
