Re: Municipal Significance designation for “NXNE” or “North by Northeast”

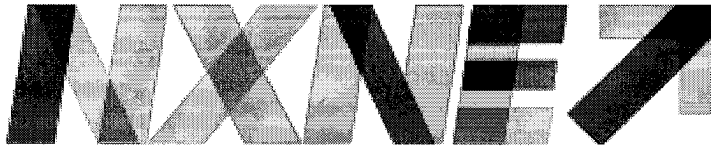
