\$264,834,697 net of all applicable taxes and charges \$299,263,208 including HST and all applicable charges \$269,495,788 net of HST recoveries

Contract is expected to start on the date of award and end on December 31, 2023.

FINANCIAL IMPACT

The total contract award identified in this report is \$299,263,208 including provisional items, contingency allowances, all applicable taxes and charges. The cost to the City is \$269,495,788 net of HST recoveries.

The engineering estimate for this project is \$317,199,100 net of all taxes and charges.

Funding is included in Toronto Water's 2018-2027 Approved Capital Budget and Plan under account CWW039-06 Outfall Construction, and the projected cash flow is summarized in Table 1.

COMMENTS

For the recommended contract award, the following requirements have been met:

a. City Council is in election recess and pursuant to the Municipal Code, Chapter 195, Purchasing, Sections 195-8.3(2), the Bid Award Panel has authority to exercise the power of a Standing Committee to make an award that exceeds \$20,000,000 (excluding applicable taxes);

- b. The firm recommended for award is the lowest bidder meeting specifications based on the evaluation criteria included in the call and meeting the requirements of the call;
- c. the appropriate Division has reviewed submissions and found the price to be reasonable, within available budget and concurs with the recommendation;
- d. the contract term is:
 - 1. for a contract funded by the operating budget, 5 years or less including any option years; or
 - 2. for a contract funded by the capital budget, within the projected term of the capital funding for the project as set out in the capital budget,

being within the delegated authority of the Bid Award Panel;

- e. there are no material written objections to the award;
- f. the call document was advertised on the City's internet website and bids were opened publicly; and
- g. the Fair Wage Office confirms the recommended firm understands the Fair Wage Policy and Labour Trades requirements and has agreed to comply fully.
