The Riverside BIA wishes to submit this letter in regard to item **BU37.8 - Street Event User Fees for Business Improvement Areas**.

The Riverside BIA, located along Queen Street East, just across the bridge from the downtown core in Ward 30, has been working with other BIAs and our local Councillor to bring this issue forward since we had learned about the proposed User Fee increases earlier this year. Our concern has always been that the fee schedules, which originally included BIAs, had been increased too much, too quickly. Given the close relationship of BIAs to the City and the way that our work leverages local business and community support for the many events that we run, mostly on a shoe-string budget, we believed BIAs should be considered in a special category.

We are pleased with the result of this review and the staff report, and feel the User Fee increases specified for BIAs are very fair. Further, the phased in approach will allow us to incorporate and plan for the increases within our budget.

A diversity of public programming including street events is a core measure of the success of our business community here in Riverside. We would ask that you support the proposal before you, which we feel enables BIAs to continue to run excellent local events throughout the city, throughout the year which benefits everyone.
