Note: The chart below responds to the Community Development and Recreation Committee motions requesting staff to report on the immediate enhancements in the Downtown East related to:

- a) Augmenting road and laneway maintenance and cleaning;
- b) Additional opportunity for increased dedicated park cleaning including flying squads;
- c) Immediate review and repair of street furniture;
- d) Increased opportunities for youth programing and children's camps;
- e) Beautification and public realm improvements; and
- f) Harm reduction and related outreach services

The recommended enhanced 12-Month Action Plan (Appendix 2) includes additional immediate actions that respond to the complex needs in the area.
