SUMMARY

The purpose of this report is to seek further instruction for the ongoing Local Planning Appeal Tribunal process on the appeals of the West Annex Phase I (Madison Avenue) Heritage Conservation District (HCD) Plan. This report seeks instruction on proposed revisions to the Madison Avenue HCD Plan.

RECOMMENDATIONS

The City Solicitor recommends that:

- 1. City Council adopt the confidential instructions to staff in Confidential Attachment 1.
- 2. City Council authorize the public release of Confidential Attachment 2 and the instructions in Confidential Attachment 1, if adopted by City Council, with the balance of Confidential Attachment 1 to remain confidential.

FINANCIAL IMPACT

Adopting this report will have no financial impact beyond what has already been approved in the current year's budget.

DECISION HISTORY

On September 30, 2015, City Council decided to designate the West Annex Phase I (Madison Avenue) Heritage Conservation District (HCD), adopt a by-law for the Madison Avenue HCD Plan, and direct the City Solicitor to appear before the Local Planning Appeal Tribunal to defend the by-law if any objections were raised.
