DECISION HISTORY

City Council on April 24, 2018 adopted CC39.8 and directed the City Solicitor and Appropriate staff to continue to oppose the Zoning By-law Amendment Application and Site Plan Applications. City Council also authorized the City Solicitor and appropriate staff to seek revisions to the Zoning By-law Amendment and to report back to City Council on the outcome of mediation and discussions if necessary. COMMENTS

A Local Planning Appeal Tribunal hearing of the zoning by-law amendment appeal and the site plan appeal was scheduled to commence for three weeks on April 30, 2018 through to May 18, 2018. A revised submission of the Zoning By-law Amendment Application was received on Friday, February 2, 2018 and again on Friday, February 23, 2018. The Applicant also submitted a revised Site Plan Application on Friday, February 23, 2018.

The City Solicitor requested and was granted an adjournment on behalf of the City. A new hearing date was not scheduled. The Local Planning Appeal Tribunal scheduled a Mediation to take place between the parties to the hearing on May 2 and May 3, 2018, and on July 5, 2018.

As directed by Council Item CC39.8, the City Solicitor along with City Staff attend the mediation sessions at the Local Planning Appeal Tribunal. The City Solicitor was instructed to report to City Council on the outcome of mediation and discussions if necessary.
