Re: Request to recognize restaurant patio expansions during the 2018 Toronto International Film Festival opening weekend and endorse 4am AGCO license extension.

Dear Members of the Toronto City Council;

We respectfully request that the Community Council and City Council advise the Alcohol and Gaming Commission of Ontario that is has no objection to requests for temporary liquor license for patio expansion from September 6 to September 16, during the 2018 Toronto International Film Festival, for the establishments listed below.

We are asking that this request be considered at the meeting of Toronto City Council scheduled for June 26, 2018.

The Toronto International Film Festival has grown to become the world's largest public film festival. We have partnered with the Entertainment District BIA to maximize the benefit to the local business community. With the approval of the closure of King St, from University Ave to Blue Jays Way for opening weekend, September 6-9, 2018, and additional lane occupations from September 10-16, 2018, TIFF has been working to assist the King St restaurants in obtaining temporary patio licenses to occupy the sidewalk and curb lane spaces of King St. These patios will encompass the south side of King St between John St and Blue Jays Way, and the north side of King St between Simcoe St and Ed Mirvish Way. TIFF will work with all operators to ensure full compliance with Alcohol and Gaming Commission of Ontario regulations, and relevant City of Toronto bylaws.
