## **Union Station Revitalization Project - Contract Amendments**

#### SUMMARY

The purpose of this report is to request authority to amend four (4) existing contracts under the Union Station Revitalization Project (USRP).

#### RECOMMENDATIONS

### The Deputy City Manager, Internal Corporate Services and Chief Purchasing Officer, Purchasing & Materials Management Division recommend that:

In accordance with Section 71-11.1.1.C of the City of Toronto Municipal Code (Financial Control By-law), City Council authorize amendment of existing contracts, in accordance with the details as specified below:

- 1. NORR Limited, Architects and Engineers, Purchase Order No. 6030175, in the additional amount of up to \$1.5 million, net of all taxes, revising the current contract authority from \$41.0 million, net of all taxes, up to a potential value of \$42.5 million, net of all taxes, to provide required additional design and construction services.
- 2. WSP Canada Group Limited, Contract No. 47020883, in the additional amount of up to \$1.5 million, net of all taxes, revising the current contract authority from \$6.4 million, net of all taxes, up to a potential value of \$7.9 million, net of all taxes, to continue to provide contract administration services and expertise through the construction duration.
- 3. Bondfield Construction Company Limited, Purchase Order No. 6041873, in the additional amount of up to \$8.8 million, net of all taxes, revising the current contract authority from \$207.2 million, net of all taxes, up to a potential value of \$216.0 million, net of all taxes, to provide construction services for the completion of USRP.

4. Osler, Hoskin & Harcourt, LLP, Purchase Order No. 6040342, in the additional amount of up to \$2.5 million, net of all taxes, revising the current contract authority from \$8.3 million, net of all taxes, up to a potential value of \$10.8 million, net of all taxes, to continue to provide construction law support and litigation services and other related consulting expertise through the construction duration, including representing the City with respect to project claims.

#### FINANCIAL IMPACT

Funding for the requested contract amendments is available in the 2018 - 2027 Council Approved Capital Budget and Plan for Facilities, Real Estate, Environment & Energy for the Union Station Revitalization Project and is within the recommended total project cost of \$823.5 million.

The contract authority increases represent upset limits and will be amended only if required. Contract increases will allow the City to address potential additional construction costs for the remaining work on the USRP, including indirect costs for consultants, and construction law and litigation support.

The Acting Chief Financial Officer has reviewed this report and agrees with the financial impact information.

#### **COMMENTS**

The recommended amendments to contract authorities will ensure the City will be able to retain the necessary third party resources to complete the project based on the updated estimated project completion date of late 2018. The revised timeline is primarily driven by the scheduling delays with other major capital projects being undertaken by Metrolinx at Union Station, along with ongoing challenges due to the historic nature of the facility and the need to maintain passenger, station and rail operations throughout construction. Amendment to the Bondfield Construction Company Limited contract authority will address potential incremental construction costs associated with the completion of stage 2/3, primarily delivery of the new Bay Concourse. Design and construction services from NORR Ltd., as well as, contract administration and professional services by WSP Canada Group Ltd will be required through the duration of the project. Current contract values for these vendors were based on the previous schedule and timeline for the USRP. The extension of this project schedule will require to extend the time, and increase authority, of these contracts to ensure these resources continue to support the project through to the end of 2018.

There are also ongoing costs associated with the defense of contractor claims. City staff continue to work with City and third party legal to ensure the City's interests are protected on all matters related to claims received on the project. The goal is to defend the City's interests against these claims, and to bring these matters to reasonable and timely conclusion. Based on the status of this claims processed to date, amendment to the Osler, Hoskin & Harcourt, LLP contract is required to ensure there is sufficient third party legal and expert support throughout the remainder of the process.

The contract authority increases represent upset limits and will be amended only if required and entitlement is justified based on the terms of the contracts. Sufficient uncommitted funds are available within the USRP approved budget to accommodate these amendments. USRP remaining work is progressing towards substantial completion and these amendments will ensure the revised schedule can be met.
