#### Recommendations

Councillor Joe Mihevc, seconded by Councillor Kristyn Wong-Tam, recommends that:

1. City Council increase the approved 2018 Capital Budget for Transportation Services on a one-time basis by \$12,000,000.00 gross, \$0 debt, towards the North York Service Road Extension project, fully funded by Section 37 (Planning Act Reserve Funds) community benefits from the following developments:

#### Summary

The Motion seeks authorization to amend Transportation Services' 2018 - 2027 Capital Plan to include additional Section 37 Planning Act Reserve Funds of \$12,000,000.00 to fund costs related to the extension of the North York Service Roads.

As part of the North York Centre Secondary Plan, an Environmental Assessment was completed in 1993 for the North York Service Road Project to support the approved levels of development in the North York Centre. The North York Service Road Project includes an extension of Doris Avenue and Beecroft Road generally between Sheppard Avenue and Finch Avenue, as parallel routes to Yonge Street.

The "Strategy for the Implementation of the North York Centre Plan Service Road-North York Centre", North York Community Council Report No. 8, Clause No. 20 was approved by City Council at its meeting of July 29, 30 and 31, 1998. The Strategy involved the use of negotiated agreements to acquire land where possible and the use of expropriation where an amicable agreement could not be reached.

Efforts to acquire property required for the North York Service Road project, either through amicable agreements or through development opportunities, where lands are acquired as a condition of development approval, are ongoing. As required lands are assembled, additional real estate and legal costs have been identified by the Transportation Services Division.

Funds have been secured through Section 37 benefits from developments at the locations noted above. The funds have been received by the City from these developments and sufficient

monies have not been spent or remain uncommitted to satisfy this Motion.
