**Authorization to Release Section 37 Funds from the Development at 4180 Dundas Street West for Upgrades to the Street Lighting at Sun Row Drive by Toronto Hydro - by Councillor John Campbell, seconded by Councillor Frances Nunziata**

**Recommendations**

Councillor John Campbell, seconded by Councillor Frances Nunziata, recommends that:

1. City Council increase the 2018 Approved Operating Budget for Non-Program by \$7,094.85 gross, \$0 net, (Cost Centre: NP2161) fully funded by Section 37 funds obtained in the development at 4180, 4186, 4186A and 4190 Dundas Street West (Source Account: XR3026-3700549), to fund improvements by Toronto Hydro to the street lighting at Sun Row Drive.
2. City Council direct that the \$7,094.85 be forwarded to Toronto Hydro upon the signing of an Undertaking by the Toronto Hydro governing the use of the funds and the financial reporting requirements.

**Summary**

This Motion seeks authorization to release Section 37 funds from the development at 4180, 4186, 4186A and 4190 Dundas Street West for upgrades to the street lighting by Alex Marchetti Park at the northern end of Sun Row Drive by Toronto Hydro.

The northern end of Sun Row Drive by the Alex Marchetti Park has been identified as a residential street lacking illumination by standard Toronto Hydro luminaries. The road does not meet regular standards for such lighting to be installed, but the condition has been identified as a safety risk by local residents. As such, implementation through external funding has been identified as the critical path to resolving the deficiency.

The cost quoted by Toronto Hydro for providing and installing the new and upgraded luminaires is \$6,972.14 (HST not included). Including non-recoverable of 1.76 percent, the required amount will be \$7,094.85.

Section 37 funds in the amount of \$72,556.58 are remaining from the development at 4180, 4186, 4186A and 4190 Dundas Street West. The funds were secured for various purposes including street lighting.

Toronto Hydro needs a City Purchase Order to initiate the project, and will then invoice the City for the cost of the Sun Row Drive lighting upgrades. This Motion proposes to provide a total of \$7,094.85 to Transportation Services to initiate a City Purchase Order for the project and pay Toronto Hydro for the work to be done.

This Motion is urgent so that the funds can be transferred in time to schedule this work to be completed over the Summer/Fall of 2018.
