SUMMARY

This report provides the City Planning Division's annual update on the Study Work Program. The report outlines the Division's 57 completions and approvals to-date in 2018 and projected completions to the end of the Council term. These completions demonstrate the Division's proactive approach to prioritizing and managing a range of complex planning issues, including large-scale city building studies, policy development, and deliverables related to building housing, transit planning and infrastructure. It also demonstrates the Division's responsiveness to new Provincial planning initiatives.

Looking ahead to 2019, the Study Work Program will reflect Council's direction and the Division's commitment to bring forward implementation strategies to support the policies and objectives of larger planning studies. Conformity with Provincial legislation, which includes review of the Official Plan's conformity with the 2017 Growth Plan including work relating to Major Transit Station Areas has been added to the Study Work Program. Also added are items related to policy development to enable the City to utilize new powers related to Inclusionary Zoning.

City Planning will also continue with local area studies and a range of planning initiatives that establish frameworks to enhance opportunities for place-making, growth-supported investment and social equity in all areas of the city.

RECOMMENDATIONS

The Chief Planner and Executive Director, City Planning recommends that:

FINANCIAL IMPACT

There are no financial implications resulting from this report.

DECISION HISTORY

The City Planning Division began providing updates on its Study Work Program through Planning and Growth Management Committee (PGMC) in October 2015. On May 11, 2016, the Chief Planner and Executive Director prepared a report for the Planning and Growth Management Committee to respond to a request for a list of the outstanding City Planning reports and studies. The request was made to improve the awareness of the magnitude of the City Planning Division's study work program. On September 8, 2016, PGMC requested the Chief Planner and Executive Director, City Planning to report yearly in September, on the Division's Study Work Program Update with the exception of an election year when the report is to be submitted to the last meeting prior to election.

COMMENTS

City Planning Study Work Program

The City Planning Division delivers a range of activities organized in two main services:

- Development Review, Decision and Implementation;
- City Building and Policy Development.

All sections of City Planning contribute to the delivery of the two services, which combine to generate the overall divisional workload. The work undertaken by the Division spans development review, heritage planning and Committee of Adjustment to forecasting, policy development, policy implementation and studies. This work is carried out by the four Community Planning Districts and the functional units (Strategic Initiatives, Policy & Analysis, Transportation Planning, Urban Design, Zoning and Committee of Adjustment).

City Planning's Study Work Program is one component of the City Building and Policy Development service. The Study Work Program captures a range of city building

activities which are reported annually to Planning and Growth Management Committee. Large study undertakings include secondary and precinct plans, *Regeneration Area* studies, transportation master plans, Heritage Conservation Districts, city-wide urban design guidelines, Official Plan Review and responses to Provincial initiatives including proposed new legislation. Other activities address local geographies such as community service and facilities strategies, area-specific urban design guidelines, or work related to green design standards and monitoring growth and demographics.

The Study Work Program applies a strategic lens to the City's role as land use planning authority by advancing implementation of the Official Plan, the City's blueprint for city building. The Official Plan is a key component of the Integrated Planning and Performance Framework outlined in City Council's Strategic Actions 2013-2018. The Strategic Actions enable a multi-year view where service planning and budgeting align and advance the Official Plan and Council's priorities.

The Study Work Program is a living document which is responsive to Divisional, Corporate and City-wide priorities. New initiatives are added to the work program either through requests from City Council or as identified by the Division in response to new public investment, growth pressures, shifts in demographic and economic conditions or legislative changes. In 2018 for example, the Province released its proposed Inclusionary Zoning regulation which required a response from the City to ensure Council's concerns were identified.

Delivering on these initiatives in a city as large as Toronto requires a rationale for prioritization that is founded upon implementing the Official Plan's vision. In determining which items to prioritize for completion, City Planning considers the following:

- 1. Integration with City Building Activity and Official Plan Vision
- 2. Alignment with Strategic Reinvestment
- 3. Identification of Key Trends or Addressing Policy Pressures
- 4. Mandated Reviews and Legislative Changes
- 5. Timelines for Decision on Key Council Priorities

In addition to this list of priorities, the Division will proceed with implementation strategies for long-term plans to realize the plans' objectives. Some examples of this include the Port Lands follow-on projects and TOcore Parks and Public Realm Implementation Strategy. Although the initial study work has been completed, the purpose of these study work program items is to identify specific targets and priorities. They may also include feasibility studies for larger capital projects. Implementation strategies also outline what planning, financial or other tools will be used to bring forward complex elements of planning frameworks that may involve other divisions (such as Transportation Services, Toronto Water, Parks Forestry & Recreation and others) and outside stakeholders (such as the Province and Metrolinx). Implementation Strategies are significant work program items and are crucial to ensuring that the analysis and effort involved in completing studies result in tangible changes, as approved by Council.

The City Planning Division tracks a work program item as "completed" when it has achieved a major public milestone, usually a report to City Council via one of its

Committees or Community Council. The completion of this milestone is the measure by which the Division tracks its service levels. Items may continue to generate workload should there be requests from City Council for additional work or consultation prior to its final consideration and approval by Council. At the request of the Planning and Growth Management Committee, the Division now tracks items as "approved". For most items, an "approved" status is achieved when it has been adopted by City Council. However, other items continue to generate workload after Council's decision and would be deemed "approved" at the conclusion of a major Ontario Municipal Board hearing or with a response to a provincial agency.

Year-to-Date: 2018 Completions and Approvals (as of June 7, 2018)

As of June 7, 2018, City Planning completed 57 items of which 29 have been approved. A full list of the Division's achievements to date is provided in Attachment 1. The list below provides information on completions by Service Levels, showing the remaining items projected to be completed by the final meeting of this term of Council:

- City Building Studies (Service Level 18): 32 completions, 10 remaining.
- Heritage Conservation District Studies/Plans (Service Level 5): 0 completions, 6 remaining.
- City-Wide Urban Design Guidelines (Service Level 1): 1 completions, 0 remaining.

Examples of 2018 completions include: Don Mills Crossing Proposed Official Plan Amendment, the Townhouse and Low-rise Apartment Guidelines, SmartTrack Stage 4 Report and the Agincourt Mall Planning Framework Review - Phase 1.

Forty-five completions are forecasted for the remainder of the Council term, of these 28 will result in a report by City Planning or a report in conjunction with another Division. Other items relate to appeals before the Local Planning Appeal Tribunal, which have stemmed from Study Work Program items. This forecast is reflective of the conclusion of Council meetings in July due to the 2018 election. Work will continue on Study Work Program items in the second half of 2018 and will be brought forward in early 2019 for reports to the appropriate committee.

Targeted 2018 completions up until the end of this term of Council include: the Danforth Planning Study - Area 1, Alternatives to On-Street Parking, Keele Finch Plus Directions and the Downsview Major Road Environmental Assessment. Additionally, two HCD studies are anticipated to be brought to the Toronto Preservation Board in July: Baby Point and Casa Loma.

2018 Defining Elements of the Study Work Program

The 2018 Study Work Program represents the Division's continued work to deliver study work related to a broad range of planning issues. Many of the items on the 2018 Study Work Program represent the culmination of multi-phased projects which have involved significant inter-divisional and inter-governmental collaboration as well as engagement with thousands of members of the public through a variety of traditional and innovative forms of consultation.

Repositioning Land Use Through Large Area Studies

In the first half of 2018, City Planning reported on the final Official Plan Amendments for TOcore, Yonge-Eglinton, ConsumersNext, Don Mills Crossing and the Unilever Precinct. These plans each address quality of life and economic opportunities, balancing residential and non-residential uses, transit networks and a range of other built form, community facility and infrastructure matters. Importantly, they build stronger linkages between population and employment growth and the timely and coordinated provision of growth-related infrastructure.

Growth Plan Conformity

The *Growth Plan*, as amended in 2017, forecasts 3.40 million people and 1.72 million jobs in the City of Toronto by 2041. As part of the Growth Plan, the City is required to establish minimum density targets for all Major Transit Station Areas (MTSAs) (including subway, LRT and GO rail) with the intent of optimizing walkability to stations and public investment in transit. City Planning must review the feasibility of meeting the Provincial targets for the over 164 MTSAs in Toronto, report on the approach to achieving conformity and conduct planning studies to support density targets and permitted uses. Work required to advance this comprehensive review will be reported out to Planning and Growth Management Committee in the first quarter of 2019. This represents a significant opportunity to link growth permissions with the provision of affordable housing and transit.

Transit Planning: Alignment, Feasibility and Land Use

The comprehensive transit planning work continues to make up a significant component of the Study Work Program. These studies involve staff across other Divisions. Transit planning includes consideration of the hard infrastructure, through preliminary route planning, engineering and station design as well as new planning frameworks to encourage growth and community building to leverage investment in rapid transit. In 2018, City Planning will have reported on 12 transit items including the Eglinton East LRT, SmartTrack and RER Stage 4. Furthermore a number of the City Building studies are underway that are examining land use direction related to transit investment including the Eglinton/Laird and Agincourt Focussed Review Phase 1.

Maintaining a Local Lens on Growth and Change

The Study Work Program includes a number of studies that address local and smaller-scale impacts of growth. These studies are situated on the *Avenues*, in *Apartment Neighbourhoods* and *Neighbourhoods*. Although local in scale, these studies can have a significant impact for Torontonians in that they are responsive to smaller geographic areas, address concerns related to proposed developments, heritage inventory and the need for new community facilities or other infrastructure. Some of these studies will result in a Site and Area Specific Policy (such as the Area-Based Character Study for High Park Apartment Neighbourhood), or special zoning based on a unique use such as the Craft Breweries Zoning Review Implementation.

Looking Ahead: 2019 Forecast

Many items forecasted for completion in 2019 are underway. As with previous years, a full forecast will be finalized at the conclusion of the 2018 City Council cycle and reported out to PGMC in the new term of Council. This forecast will take into account additional items added by Council and the scheduling of LPAT hearings.

The overall number of items forecasted for 2019 is 148. This number is greater than the total number of items forecasted to be delivered in 2018, partially due to the number of potential Council meetings scheduled in 2019. In 2019 a number of City Building studies are expected to be completed including the Golden Mile Secondary Plan Phase 2, Queensway Area Study and Jane Finch Secondary Plan Phase 1. Built Form, Implementation and Infrastructure Strategies for TOcore, Yonge-Eglinton and the Port Lands will also be completed. New draft Official Plan policies related to Inclusionary Housing and Built Form and Public Realm policies will be completed in 2019. The new City-wide Pet Friendly Design Guidelines will be completed as will seven Heritage Conservation District Studies and Plans.

Planning studies for transit lines such as Eglinton East and West LRT will be reported in the first half of the year; and a number of Transit assessments, transportation master plans and transportation planning studies are underway, which are listed in Attachment 2.

Studies will include additional analysis of heritage resources and zoning requirements so that City Building Studies include consideration of these in density targets, as the City achieves Growth Plan conformity.

Drivers of Future Work: a City-Wide Lens

The Study Work Program is responsive to emerging issues and priorities facing the city. The Division will also assess how other areas of the city can benefit from and share the rewards and advantages of living in Toronto. This work will involve applying a social equity and inclusion lens in forthcoming study work. As identified in the Official Plan, some neighbourhoods may need to be strengthened to ensure a better quality of life for their residents. In 2018, the Division is initiating the Mount Dennis Planning Study and will be providing input to the forthcoming Request for Expressions of Interest for the revitalization of four Toronto Community Housing communities. In each of these cases, studies will involve leveraging the benefits of transit investment and local assets to engage in place-making projects, improve access and opportunity to housing and employment options, access to services community facilities and amenities and improve connectivity locally and across the city.

As reported in May 2018, the Growth Plan sets out a number of requirements that will have an impact on the City Planning Division's 2019-2022 work program. A significant amount of work will need to be undertaken to address the legislated requirement to bring the Official Plan into conformity with the Growth Plan 2017 and to advance the required zoning by-law and implementation frameworks. The city-wide exercise to review density targets for Major Transit Station Areas, which will include accelerating and advancing zoning frameworks, will occupy significant staff resources. The Division

is continuing its ongoing engagement with multidisciplinary teams to advance other Council objectives such as affordable housing, shelters, poverty reduction and revitalization of social housing communities (with Toronto Community Housing).

City-wide, new development applications are being received for renewal and intensification of large retail areas. Both Yorkdale Mall and Agincourt Mall are examples with more expected in the coming years. These applications have a broader Study Work Program impact; the scale of the proposals necessitate a comprehensive review of transportation and infrastructure, built form, housing issues, parkland provision and community services and facilities.

The City Planning Division has also aligned its study work with other complementary corporate city-wide study processes. The most notable of these is currently the Parkland Strategy. The Parkland Strategy is a 20-year plan that will guide long-term planning for new parks and expansion and improved access to existing parks. It will aid in the decision-making and prioritization of investment in parkland across the city. The Division is providing strategic input on this document which will inform the Official Plan Amendment to the Parks and Open Space policies and alternative rate by-law.

Other Items and Requests

In 2016, the Planning and Growth Management Committee requested a complete list of all other requests of City Planning beyond the two-year prioritized Study Work Program. This list was presented to Planning and Growth Management Committee at its meeting of September 8, 2016. These items are identified in the Study Work Program but not scheduled for completion in 2018 or 2019 (Attachment 3). Items on hold may be derived from additional requests of the Division from motions made by City Council and its Committees.

Attachment 3: Study Work Program - Beyond the Current Council Term

Attachment 3 lists items that are on the Study Work Program with anticipated completion in 2020 or beyond. This includes the Polson Quay Precinct Plan, Scarborough Centre Focused Review and the Finch Goods Movement Study. This list also includes potential studies that are on hold. Studies may be on hold as result of resource constraints to undertake the work, or potential duplication with broader studies. Hold items may be brought forward to the list of Active items based on availability of resources or a shift in Divisional or City-wide priorities.

Conclusion

Over the 2014-2018 Council Term, City Planning has consistently managed a robust and diverse Study Work Program. The studies being undertaken by the Division represent a workload touching all aspects of city building. Achieving the completions and approvals (57 to-date in 2018) also reflects the involvement of multiple stakeholders from other City Divisions; engaging city staff from outside City Planning has been an approach which is reflected in positive outcomes for the Study Work Program.

The Study Work Program, including Active Projects from Attachment 1, and the total projects in Attachments 2-3 capture 242 items. This volume of work is actively managed by City Planning to advance the implementation Toronto's Official Plan vision. This report highlights how the City Planning Division prioritizes these demands and points to the studies that will shape the work of the Division over the long-term.
