Community Improvement Plan to Implement Changes to the Imagination, Manufacturing, Innovation and Technology (IMIT) Program

Toronto City Council will be considering recommendations to pass a by-law to implement a new City-Wide Community Improvement Plan (CIP) that enables the Imagination, Manufacturing, Innovation and Technology (IMIT) incentive Program. At the same time, Toronto City Council will consider amendments to City of Toronto Municipal Code Chapter 441, Fees and Charges, so as to authorize the charging of an administration fee of 30 cents per square metre based on eligible gross floor area for projects receiving IMIT Development Grants, commencing in 2019.

It is proposed that the by-law be adopted at the Council meeting to be held on July 23, 24 and 25, 2018 or at a subsequent meeting.

The proposed IMIT administration fee is outlined in the report titled "Community Improvement Plan to Implement Changes to the IMIT Program".
