PROPOSAL

In July 2016, the City of Toronto initiated the Scarborough Centre Transportation Master Plan (SCTMP) study. Throughout the study process, staff engaged in extensive public and stakeholder consultation, including 3 public consultation meetings and 3 Local Advisory Committee meetings. A preferred transportation network was presented to the public for input on November 22nd, 2017.

The SCTMP provides the framework and direction for the transportation network within Scarborough Centre to support the Secondary Plan vision for a connected and vibrant urban centre. The proposed Official Plan Amendments would bring forward changes to implement the vision and transportation network identified through the SCTMP study and consultations.


