PROPOSAL

The purpose of the application is to amend the former City of Scarborough, West Hill Community Zoning By-law Number 10327 and the City of Toronto Zoning By-law Number 569-2013 by applying site specific regulations in order to permit the creation of eight lots, each with a detached dwelling, having access from an 8 metre private road for the property located at 4342 Lawrence Avenue East.

A consent application (B0017/18SC) has been filed with the Committee of Adjustment for the creation of the eight lots.


If you wish to be notified of the passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk, attention: Administrator, Scarborough Community Council, at the address, fax number or e-mail set out in this notice.

Zoning By-law Amendment Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the by-law is passed or refused, the person or public body is not entitled to appeal the decision. You may submit comments to the City Clerk, Attn: Administrator, Scarborough Community Council, at the address, fax number or e-mail set out in this notice.

People writing or making presentations at the public meeting: The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.
